#### Section 1: Background Information/Brief History of involvement

There has been no previous social care involvement from social care prior to the current referral.

Joe and his family were referred to social care 21.01.18 due to an incident were Joe went missing for two days and refused to come home following an altercation with his parents.

Joe has been refusing to attend school for a number of months and his attendance has been sporadic.

A single assessment of the family has been completed, Joe is subject to a child in need plan under Section 17 of the CA 1989.

The family are receiving statutory visits once a fortnight including unannounced visits monthly, this will be reviewed at the next CIN meeting 28.04.18

# Section 2: The Views, strengths, interests and aspirations of the child, their parent/carer or the young person

During my initial assessment with the family and through telephone conversations with parents the following the views, strengths, interests and aspirations of Joe and his parents were captured.

It is important to Joe that he is allowed to be as independent as possible.

Joe has stated that he doesn't want to always have his parents with him when he goes out in the community.

Joe has stated that he wants to feel good about going to school and would like to go to college to study IT when he leaves school.

Mum/Dad want Joe to remain living with them and to better understand his diagnosis of Autism so they can support him effectively.

Mum/Dad would like Joe to have some pro-social friends that he can attend activities with. Parents would like Joe to gain the skills to develop long term friendships. Joe has also agreed that he would like to spend more of his free time with friends.

Joe has stated that he would not like to be part of future meetings however he would like his voice heard through written updates passed through parents.

#### Section 3: Social Care needs/difficulties

The following social care needs/difficulties were identified through the child and family assessment that was completed with Joe and his family 02.02.18

Joe has a diagnosis of Autism.

Joe finds it difficult to maintain friendships as he cannot easily recognise social cues and struggles to make and maintain friendships. This means that Joe can be socially isolated outside of the structure of the school day. Joe struggles in social situations, particularly with children his own age. He has recently started to attend a local Youth hub, which provides him with a structured approach to social situations outside of school. However his anxiety about using public transport alone prevents him from attending more often.

Joe's parents have stated that they are finding it increasingly difficult to manage Joe's behaviour as he is becoming more challenging at home, this results in him monopolising his mother's time. This makes it difficult for her to provide care for Joe's younger siblings and causes great stress within the family.

Parents have reported Joe missing from home on a number of occasions and have said that his missing from home episodes alongside their struggles at managing behaviour are currently impacting on his attendance at school and educational attainment.

# Section 4: Outcomes Sought for the child or young person relating to social care needs/difficulties

Joe has the confidence to attend the Youth hub twice a week.

Joe will engage in an activity with 2 peers each week at the youth hub with minimal adult guidance by the end of the year.

Joe will initiate a conversation with a peer at least once per week during Youth Hub without any adult prompts by the end of term.

Joe will have at least two pro social friends whom he sees outside of school times, and Joe will report being more confident in developing and maintaining friendships.

Mum and Dad to gain a better understanding of Joe's Autism diagnosis to enable them to communicate more effectively with Joe and understand how to implement effective behaviour strategies.

Joe's attendance at school to improve by the end of next term to at least 80%
